AIR MEDAL--By direction of the President, under the provisions of Executive Order No. 9158, 11 May 1942 (Bull 25, 7D, 1942), as anonded by Executive Order No. 9242-A, 11 September 1942 (Bull 49, 7D, 1942), and pursuant to authority delegated by the Deputy Commander, Twentieth Air Force in classified letter, file AG 323.361 subject: "Definition of Administrative Responsibilities", dated 18 December 1944, announcement is made of the award of the Air Medal to the following named officers and enlisted men, organizations indicated:
